## Annual Member Meeting: November 16

The Timber Creek Homeowners annual owners meeting will be held on Saturday, November 16, beginning at 11:00 am at the Sisters City Hall.

Since there was no quorum present at the meeting scheduled for August 24, the meeting was rescheduled to November. At least 44 lots must be represented, either in person or by proxy, for the November meeting to occur.

These items will be on the agenda for the owners meeting:

- 1. Election of two directors to serve 3-year terms beginning in January 2014.
- 2. Approval of a motion to carry forward to 2014 any remaining funds from the 2013 operating fund.

## Nominations for Director

Owners will elect two directors to the Homeowner Association's Board for three-year terms beginning in January, 2014. The Nominating Committee has recommended three candidates for owners to consider for the two vacancies. Additional candidates may be nominated at the meeting.

# Reminders...

Owners and tenants are asked to:

- Obtain approval of the Architectural Review Committee before making a change to the exterior appearance of a home, or making an improvement to the property, such as construction or alteration of a fence, wall, privacy screen, storage shelter, or landscaping, installing a satellite dish, etc.
- Keep garbage and refuse containers or fuel tanks out of view of neighboring lots or the street.
- Not park motor homes, boats, or trailers on the street or in driveways for longer than 48 hours.
- Keep all dogs on leash.
- Not feed the deer.
- Post no signs. Exceptions include a sign with the name of the owner or residence, or a home "For Sale" sign.
